## ELLETTSVILLE POLICE RECEIVE LOCAL C.A.R.E.S. GRANT – AUGUST 19, 2016

The Monroe County C.A.R.E.S. Board recommended to the Monroe County Commissioners that the Ellettsville Police Department be awarded a grant totaling \$9,250.39 to support our department's efforts in detecting and arresting violations of Indiana's drug and alcohol laws. The money was presented at the August 19, 2016 Monroe County Commissioners meeting. The money will allow the purchase of additional in-car video cameras to record interactions between officers and suspected violators of drug and alcohol laws.

The money that the Monroe County C.A.R.E.S. Board provides to local agencies comes from the court fees that are assessed against those convicted of violations of drug and alcohol laws, as required by the Indiana State Law.



#### MOTORIST FOUND SLEEPING IN ATM DRIVE-THRU HAD METHAMPHETAMINE AND ARREST WARRANTS – AUGUST 6, 2016

Officer Zachary Michael found a silver Dodge Durango sitting in the ATM drive-thru just before 3:00 AM on Saturday, August 6, 2016, at Chase Bank, located at 4141 West State Road 46. Officer Michael had observed the car there approximately forty-five minutes before when he had passed by and on his way back he noticed it was still sitting at the ATM with the lights on and the motor running. Officer Michael approached the vehicle on foot and found the driver to be slumped over the wheel. Officer Michael recognized the driver from previous encounters to be Ryan Schmidt (age 38) of Bloomington. Schmidt was also known to have two valid arrest warrants. Sergeant Russell Harris of the Ellettsville Police Department arrived to assist and they made contact with Schmidt, who was found to be in possession of methamphetamine and a pipe that had been used to smoke methamphetamine.

Ryan Schmidt was transported and booked on the following charges:

- 1. Possession of Methamphetamine, a Level 6 Felony, under I.C. 35-48-4-6.1.
- 2. Possession of Paraphernalia, a Class C Misdemeanor, under I.C. 35-48-4-8.3.
- 3. Monroe County warrant for Criminal Confinement, a Level 6 Felony, under I.C. 35-42-3-3(a), and Domestic Battery Resulting in Moderate Bodily Injury, a Level 6 Felony, under I.C. 35-42-2-1.3(a).
- 4. Monroe County Warrant for Domestic Battery, a Class A Misdemeanor, under I.C. 35-42-2-1.3(a).
