## ELLETTSVILLE POLICE AWARDED COMMUNITY APPRECIATION GIFTS – JULY 23, 2016

#### WOMAN AND INFANT CHILD HELD CAPTIVE IN ELLETTSVILLE APARTMENT – JULY 23, 2016

On Saturday, July 23, 2016 at approximately 10:30 AM, Administrative Deputy Chief Anthony Bowlen and Officer Alva Bohall of the Ellettsville Police Department were dispatched to an

apartment on Raub's Lane to check on the welfare of an individual and her infant daughter. The victim's sister in Illinois had received a text message that the victim and her daughter were being held against their will by an acquaintance of the victim. Efforts to make contact were unsuccessful and no one answered the door or cellular phone numbers obtained from family members. Administrative Deputy Chief Bowlen was able to listen through the wall for a short period of time until he heard the sound of movement come from inside the apartment. Officer Bohall then forced entry into the apartment where officers found Dominique Sha Nese Irby (age 24) of Bloomington along with the victim and her infant daughter. The victim reported that Irby had been holding her and her infant child against their will. Dominique Irby was found to be wanted on a warrant out of Monroe County for Violation of Probation on the original charge of Neglect of a Dependent Resulting in Bodily Injury, a Level 5 Felony.

The victim reported that Irby had arrived on Wednesday, July 20, 2016 and had held her and her child inside the apartment against their will since that time. The victim told officers that she was not allowed to open the door for anyone and was not allowed to make any noise. The victim was not allowed to make any phone calls or have contact with anyone. Early Saturday morning, the victim had an opportunity to send her sister a text message asking for her to contact the police. The victim and her child were not injured during the ordeal.

Dominique Sha Nese Irby was arrested and transported to Monroe County Correctional Facility where she was booked on the following charges:

- 1. Criminal Confinement, under I.C. 35-42-3-3(a), a Level 6 Felony
- 2. Criminal Confinement of a person less than 14 years of age, under I.C. 35-42-3-1(a), a Level 5 Felony
- 3. Warrant for Violation of Probation, original Charge of Neglect of a Dependent Resulting in Bodily Injury, under I.C. 35-46-1-4, a Level 5 Felony

## MARION COUNTY FUGITIVE APPREHENDED IN ELLETTSVILLE – JULY 21, 2016

On Thursday, July 21, 2016 just after 12:00 PM, members of the Ellettsville Police Department and Monroe County Sheriff's Office served an arrest warrant for Violation of Parole on Timothy Brian Helton (age 36) of Bunker Hill, Indiana at a residence on West Main Street in Ellettsville. The resident is a relative of Helton's. Helton had violated parole and had been wanted on warrant since May 23, 2016. When police found Helton, he was found hiding in a room at the Main Street Residence and arrested without further incident.

#### ELLETTSVILLE POLICE DEPARTMENT ASSISTS WITH INDIANA UNIVERSITY POLICE ACADEMY – JULY 15, 2016

On Friday, July 15, 2016 Officer Alec Leggio and Officer Zachary Michael participated as role players and guest instructors at one of the practical exercises for the Indiana University Police Academy. The Indiana University Police Academy certifies full-time students at Indiana University as police officers. Once students graduate from the academy they perform the same functions of full-time police officers at Indiana University. Officer Leggio and Officer Michael are both graduates of this program and worked part-time for the Indiana University Police

Department (Bloomington campus) before beginning their careers at the Ellettsville Police Department.

This particular practical exercise allowed students to demonstrate their knowledge and understanding of, among many other things, proper tactics for traffic stops, "verbal judo" for diffusing tense situations, and defensive tactics in the event an individual is uncooperative or combative.

Officer Michael also gave the students a demonstration on the department's electronic control device, the TASER X2. Interested students volunteered to be subject to a deployment of the TASER X2 to better understand its effects.



#### **CITIZEN REPORTS HELP END THEFT SPREE – JULY 13, 2016**

On Saturday, July 9, 2016, the Ellettsville Police Department began receiving complaints from numerous residents in the area of Ritter Street, Dewey Drive and Seneca Street, complaining that they had left their vehicles unlocked and returned to find someone had went through their vehicles and in most cases, items such as change, etc. were stolen from the vehicles. On Wednesday, July 13, 2016 in the afternoon hours, residents in the area of Deer Run called in a complaint that a male had been seen entering their vehicle. The male left prior to the officer's arrival. Shortly after, a resident in Arrowhead Subdivision called in to report that a male subject who matched the description from the call on Deer Run had tried to steal a bicycle on Miami Street. The male was apprehended by Sergeant Craig Davis and identified as Joshua Terrell (18 years old) of Ellettsville, Indiana.

Joshua Terrell was booked on the following charges:

- 1. Possession of Controlled Substance 35-48-4-7, Class A Misdemeanor.
- 2. Unauthorized entry to a motor vehicle 35-43-4-2.7, Class B Misdemeanor.

We highly encourage all of our residents to be vigilant in locking not only your vehicles, but also your homes and all outbuildings.
